2.1 Snow Removal.

Staff reviewed the snow removal procedures & parking in residential and commercial areas of town. The Council consented to continue residential snow rules of no parking on city streets until snow is cleared curb to curb. Staff raised the question of whether to tow or ticket vehicles on side streets during a snow event? Discussion was held regarding downtown areas that included signage and parking in commercial areas. What areas of town are considered downtown? The question was asked what do business owners think of parking on the downtown streets. Council wants to bring this back to the October 28th meeting; they want a policy in place for the November newsletter. Council asked what is the snow plow routes; what areas are done first, second, etc. The Council also discussed damage to private property caused by a snowplow truck. Voigt stated we currently fix mailboxes if they were actually hit by the plow/truck. If the mailbox was hit by snow we will not fix it. Lawn repairs are fixed if it is damage from the trucks/plow blade. Staff brought up cleaning of snow on sidewalks that abut residential properties.

3. Introductions, Presentations, Proclamations, Awards, and Public Comment

3.1 Deputy Matt Arnst Quarterly Report

Deputy Arnst reported they have had extra traffic enforcement on Elm Street to County Road 31 the last few months due to increased speeding. The digital speed limit sign will be moved and monitored. He also reported they are patrolling the city composite site during random times of the day in order to deter illegal dumping by commercial entities. Arnst suggested securing this area during non-business hours and establishing certain hours for the residents of NYA to do their composite drop offs. Arnst also commented on the preparations for the upcoming snow removal in the downtown districts. His suggestion is to continue the current procedure of cleaning off sidewalks, then sides of streets to allow business parking during business hours and remove the center snow during non-business hours. Arnst also suggested to adopt language to open up city parking lots for off-street parking during snow removal.

7.1 Consider Sinclair Food Mart Outdoor Storage Clean-up Deadline Extension Request Administrator Helget reported the original clean up deadline was September 9, 2019 and Council agreed to extend it to October 8, 2019. After conversation with property owner Russ Smith, Helget will be researching when the City Code changed to restrict outdoor storage and how much said property was allowed for outdoor storage at that time. All records of allowable storage will be filed with the property information. Motion: DS/MM to approve new deadline for clean-up of outdoor storage to October 30, 2019. Vote 5 - 0. Motion carried.

7.2 Consider OrangeBall Creative 2020 Highway 212 Construction Marketing Proposal Representatives John Gamades and Jessica Klaustermeier from OrangeBall Creative were present to review their marketing campaign proposal, terms, and communications throughout the project.

Helget will draft a written agreement between the City and Booster Club which outlines responsibilities and liability issues.

SUBJECT: Highway 5/25/CSAH 33 Roundabout Project

Andrew Engel and Darrin Mielke representing Carver County Public Works will be present to provide an update on the plans for the 2020 Highway 5/25/CSAH 33 Roundabout Project. In addition, the following other items will be presented

- Approval of the enclosed Joint Powers Agreement (JPA) between the City and Carver County. This agreement outlines the duties and responsibilities of each agency. It also outlines the costs associated (see the enclosed spread sheet). The City's cost share is an estimate based on the County's 95% plans completion.
- 2. Approval of the enclosed Resolution 2019-24, Limited Use Permit (LUP) for the 10' wide bituminous trail to be installed along Reform Street. Approval of this resolution is a MnDOT requirement for all trails located within, or partially within MnDOT's right-of-way. The purpose of LUP is primarily to reflect that the trail is located within the right-of-way by permit, and not to be considered for future park projects which will avoid any future environmental implications. It also outlines the responsibilities of the City and MnDOT in the construction and maintenance of the trail.
- 3. Authorization for the City Engineer to sign the plans. This is how municipal consent is handled for County projects within the city limits.

Consider 519 Elm Street W. Home Occupation Violation Compliance Extension

Derek and Katie Jensen are the owners of the property located at 519 Elm Street W. Upon inspection of their property it was determined that the vehicles and trailers affiliated with their home occupation are being stored outdoors on the property.

The property in question is zoned R-3, Medium Density Mixed Residential and home occupations is a permitted accessory use. According to Section 1245.09 (Home Occupations) of the City Code, contractor storage yards are prohibited. It is considered a violation of the City's Zoning Code for the business-related vehicles and trailers to be parked outdoors on the subject property.

Enclosed is a copy of the letter and attachments sent to Mr. and Mrs. Jensen on September 20, 2019. In accordance with Section 120 of the City Code, for violations of the City's Zoning Code, the property owners have 30-days from the issuance of the written notice of the violation to: 1) come into compliance, 2) request an administrative hearing, or 3) provide the city administrator with satisfactory written evidence of efforts towards compliance.

Mr. and Mrs. Jensen are requesting the City Council consider extending the compliance deadline.

Consider Outstanding Bonded Indebtedness Refinancing Options

The City utilizes Ehlers as its financial consultant and one of their roles is to monitor the City's outstanding bonded indebtedness and to identify refinancing/refunding opportunities. Enclosed is a memo from Nick Anhut, Ehlers, which identifies 5 bonds that are either callable now or will be next year. Mr. Anhut will review the refunding options, potential interest savings, and Bond Rating consideration.

In respect to the City's Bond Rating, the last bond rating was completed by Standard's & Poor's in 2016. Enclosed is a copy of that report.

Mr. Anhut will also be prepared to discuss options for the 2020 bond issuance for the Highway 212 Underpass Project.

SUBJECT:

Hwy 212E Right Turn Lane to Heritage Strip Mall Request to MnDOT

Background

Over the past decade, the city of Norwood Young America has had multiple businesses decline construction or relocation to Railroad Drive or the Heritage Strip Mall area due to access limitations from Highway 212 east. MnDOT traffic engineers have previously stated they do not favor a right turn lane because there is adequate access from Railroad Street and their preference is, for traffic safety purposes, to remove accesses from Highway 212 versus adding them.

Norwood Young America has very few bare-land commercial properties located within the city limits and this accessibility issue limits the economic growth of a major commercial property. The visibility from Highway 212 to Railroad Street is acceptable, however the "how to get there" factor is the challenge. Unfortunately, MnDOT is at the 95% completion of the design plans for the 2020 Highway 212 Mill & Overlay project. It is unlikely MnDOT will be able to incorporate a right turning lane into the project because of the timing factor, however, this limitation needs to be brought to their attention again due to the negative economic impact it has for the current and prospective business community.

Suggested City Council Action:

It is City staff's recommendation to have the City Council make a formal written request to MnDOT representatives to review this limited accessibility issue to the Heritage Strip Mall.
