#### 4.2 Peace Villa

Peace Villa looking at building improvements in March with a deferred loan. Waiting list for couples is 9-12 months and 24 months for single. 9 turnovers and 7 deaths.

#### 4.3 Oak Grove

Oak Grove apartments are full. There will be an Elvis impersonator for Valentine's Day. New Oak Grove manager is Anne Marie Stolp who has worked for the Carver County CDA for 12 years and has over 30 years of experience.
