# NORWOOD YOUNG AMERICA PARKS AND RECREATION COMMISSION Tuesday March 14, 2022 Meeting at 4:45pm in Council Chambers minutes

**1. Call to Order;** CS at 4:46pm **1.1.** *Pledge of Allegiance* 

- 2. Adoption of Agenda; KH informed the commission her role will the city will include performing more duties as a Community Development role in the future, especially with the bigger projects. KH presented additions to the agenda which included 6.2 Park Dedication Funds, 5.4 Willkommen Memorial Park, and 5.5 Trail & Sidewalk Maintenance. SF made amotion to approved agenda with additions, DS second, vote passed 5-0.
- 3. Approve Minutes Of 3-15-2021 meeting; BG made a motion to approve the minutes, SF second, vote passed 5-0.
- 4. Introductions, Presentations, and Public Comment

Mayor Lagergren presented information from Paul Hallquist students in his Computer Applications class at Central School. CL stated the students worked on writing letters to the City in regards to the condition of the parks and possible updates and upgrades to each park which included updating the ramps, redoing the concrete, and adding a drinking fountain to the Skate Park, adding a dog park, pool updates and upgrades, Friendship Park projects as well as adding to Prairie Dawn Park. CL also shared the Parks could work with the school to offer volunteers for the Arbor Day tree planting.

5. Old Business/Goals (Updates)

5.1 Legion Park Playground Replacement, Brett Altergott with Flagship Recreation will be present Brent Altergott presented information along with color examples. CS asked about the slide discolor or fading? BA said tan and leaf not as susceptible to fade. BA recommended to stay away from yellow and red. BA stated the darker colors are warm but not hot. CS asked about PVC decks resisting cracking in cold weather? BA said it will resist cracking from most elements except vandalism. BA also stated the company is out of Delano, MN and will replace any part that has a defect. BA stated the decks are griptex, they use aluminum posts, netting is steel reinforced and fool proof, all lumber is recycled and maintenance free. BA stated if ordered by April 22, delivery would be in June with a July delivery and they will deliver to site day of installation. TV asked if we can get paint to match to paint

the existing swing poles, BA stated he could get matching paint. BA presented three color options of AH, AI and AO. BG, DS, SF and JZ all agreed AO was the color option to order.

#### 5.2 Central Softball Fencing Proposal, Darrin Fox

Tim Mueller presented the information in the packet. TM mentioned the ag-lime is washing near the edge of the batting cages, TV said he will look at it. TM asked about the time-line in regards to permanent fencing at the parks? CS asked TM to get estimates back to the city before June to be considered in the 2023 budget.

#### 5.3 Public Water Access on Barnes Lake

KH presented the information in the memo and stated summer of 2022 in the goal to complete the community survey. CS asked about getting the survey out in the newsletter? KH stated yes they could get it out to everyone that way including personally notifying the Meadows resident of the trail and dock impact. KH stated they plan to possibly use survey monkey for research. KH plans to bring back survey questions at the April meeting.

#### 5.4 Splash Pad

TV presented the information in the memo. CS asked for budget numbers and layout, where it fits, and where to place considering the existing pool or a different park. TV stated he will work with a designer and bring back info either at the April or May meeting.

#### 5.5 Old Town Update

KH presented information in the memo. KH stated renovation is not cost effective with issues regarding ADA entrances, upstairs rooms having large enough room occupancy to demand an elevator and fire suppression, and tough to budget what you may find for rot when you tear apart the walls. KH stated the foundation is good. KH talked about adding one ADA door on the east side by the new staircase under the bell tower and crows nest. KS stated they are working with and architect off the original Old Town plans. SF stated she was glad to see something finally happening with it and they are doing a good job. DS asked if the RFQ will be for the architect? KH stated yes, so we know how much plans will be. CS asked for a motion to send out RFQ's. Motion by SF, Second by DS to send out RFQ's, motion passed 5-0.

#### **Bench Donations**

I plan to place an order in early April. We have one donation so far for this order. TV had no updates.

#### West Carver Community Pool, resurface plaster in lap pool

We are on the schedule to have the project demo started mid-April. Go Get Fred has about 1 week of demo and prep work to complete. Plaster will commence after the demo is finished and the weather cooperates. TV stated the work is on track and he plans to stay in contact with Go Get Fred.

#### Trail and Sidewalk Maintenance

TV stated he had no updates but will be working on concrete leveling and replacement this year.

#### 6. New Business

#### **6.1 Arbor Day Tree Planting**

TV presented the information in the memo. CS suggested contacting the school for volunteers on the April 29<sup>th</sup> planting day. DS stated Friday would be better than Saturday. CS asked that the trees get marked and mapped along Faxon before the April meeting. KH stated Elm St needs trees as well. BG commented on the tree grates pushing up and causing trip hazards. CS stated this is a maintenance item. SF asked that TV picks the right species to plant. KH stated we will work on purposeful planting.

#### 6.2 Park Dedication Funds

AB stated the city had about \$60,000 in the fund and it is setup up under state statutes. AB stated the money is meant for improvements not maintenance. AB stated different developments have different amounts. CS asked if we could use the money for engineer costs of the new trail off Lakewood Trail? AB thought that may qualify. KH stated this money is totally different then regular budget. AB also stated the capital and general budget are 2 sperate items as well. CS asked that the 2022 Parks Goals be included in the packet each month.

Legion Park Playground Replacement

The equipment purchase has been approved and the order was confirmed with Flagship Recreation. Flagship Recreation expects the equipment availability and shipment date will be June 29. Flagship has installation crews available soon after that date. Flagship will not deliver the equipment until they are ready to install.

Public Services staff will coordinate the removal and disposal of the existing equipment and playground bedding in preparation for the installation at the site. When Flagship Recreation is complete with the equipment installation, staff will install new playground bedding and restore any damage to the site. Staff intends to paint the existing swing poles to match the new playground equipment once it is installed.

RE: Splash Pad Update

Staff is working with a recreation equipment supplier to explore options and budgeting for a splash pad. The previous memo included some rough budgetary numbers ranging from \$193,000 to well over \$475,000 for splash pad equipment and a recirculation system.

After researching the amount of water a drain away system uses versus a recirculation system, the Public Services Department strongly discourages a drain away system. The amount of water loss to the system can be upwards of 25% of your summer daily average or approximately 120,000-130,000 gallons per day. That would equate to approximately 11,700,000 gallons of water lost in the months of June-August. The City should be concerned and protective of their fresh water since it is their most precious resource.

Staff plans to have more information at the May meeting which will include more detailed costs estimates, probable locations, and possibly a presentation from a recreation equipment supplier.

RE: Alternative donation bench option

There was discussion at the January Joint Commission meeting in regard to the current Park donation benches. It was identified that the benches are starting to show their age on the ends of the bench which are painted green. The Joint Commission asked if the City would look into other bench options that would be totally maintenance free.

Our current City benches have aluminum side plates. As the aluminum ages, it starts to corrode and release the paint on the sides of the benches. This does not impact the strength or durability of the bench, but leaves it looking not as nice as when the bench was new. The seating boards of the bench consist of a composite wood that is aging very well requiring little to no maintenance. The Public Services Staff intend to continue painting the current benches to keep them looking nice.

The current City donation bench purchased from Tangent Materials recently had some price increases that make this an opportune time to investigate other options. The current 6' Park donation bench costs the City \$885 for the bench, \$45 per line for engraving, and \$150-\$245 for shipping dependent upon how many benches are on the order. The typical order contains 2 lines of engraving bring the grand total for the bench purchase to \$1125-\$1220 per bench.

Staff researched available options of totally maintenance free benches and included some information in the packet. The proposed option from By The Yard would be \$926.10 for the bench, \$100 for engraving, and \$49 to ship. The By The Yard Horizon bench would cost \$1075.10 engraved and shipped. The Horizon bench has a large upper board on the back of the bench that can be engraved. This board offers enough space to comfortably fit 2 lines of engraving, which is a majority of what the City receives for engraving requests. By The Yard offers an assortment of color options and will allow the seating boards to be different color then the ends of the seat frames to look similar to the City's current benches.



RE: West Carver Community Pool Update

The plaster project for the pool is on the schedule for this year. Staff continues to stay in contact with Go Get Fred to complete the project. Go Get Fred plans to start the project the week of April 18<sup>th</sup>. They have about a week of demo and prep work to complete. Once that is complete, they will plaster the pool dependent upon the weather. Go Get Fred plans to have the pool ready to fill by the first or second week of May. Staff will then need to fill the pool and maintain water quality for a minimum of 30 days to cure the plaster.

The project should be complete, and the pool should be available to open before the Lifeguard Staff needs the pool for instructional purposes and the official open date of the pool which will be late May or early June.

RE: Trail Maintenance Update

The Public Services Staff has prepared RFQ's to complete asphalt trail maintenance for this year. The proposed project is crack filling the newest city trail in Prairie Dawn Park that leads up to Lakewood Ct and the Serenity Pointe Trail between Tacoma Ave and Industrial Boulevard. The project also consists of sealcoating the existing trail through Prairie Dawn Park by the playground equipment. If approved, the projects are slated for completion by the end of August.

Public Services Staff is continuing to identify trip hazards and will propose more slab raising and concrete replacement on the City sidewalks at a later date.
