1. Call meeting to Order

Kroells called the meeting to order at 9:00 am.

2. Pledge of Allegiance

3. Adopt Agenda

5. Updates

- 5.1 Senior Residence Updates
 - a. Harbor/Haven
 - Hallquist shared and email update from Hilgers: Harbor has 5 open apartments 1 reserved, 1 pending, Haven 7 open, 3 reserved, 2 pending, Reflections is full. We still have multiple open positions as a Resident Assistant. A note from Hilgers, "We are also looking for a FT RN, FT Resident Services Coordinator (staffing scheduler) & a FT marketing person. On March 31, Ecumen announced that they will terminate their management agreement with The Harbor and The Haven on July 31, 2023. Ecumen is making this change due the ongoing operational challenges and market conditions outside of their control and thus have made the decision to close their business line that serves city, county and other government agencies. Services and staff will remain intact and we are hopeful for a smooth transition to a new management company. To add to the above, Requests for Proposals have been sent out to prospective management companies and 2 were on site and toured with myself and the owners recently. There were another 2 companies interested as well. We are now awaiting for the proposals to come in."
 - b. Peace Villa
 - Schmitz shared that PV is 100% occupied and construction is completed. She welcomed all to visit to check out the new community areas. An open house date is yet to be determined.
 - c. Oak Grove
 - Hampshire shared the new manager is here one afternoon per week. There are 2 two bed/two bath apartments open.
