Vice Chair Gerth called the meeting to order at 6:00pm.

5. New Business

A. NYA Business Dashboard

Hallquist shared that the Farmers Insurance Agency ribbon cutting should be in August. More businesses contacting staff to get information on the industrial park expansion. Parks and Recreation Commission recommending a Memorial Tree Program to the City Council. 232 E Main Street sold to a couple who will be putting in a photography studio in the front 50% of the building and apartment in the back.

6. Old Business/Update

A. Housing Study Update

Hallquist shared that she was notified by the Carver Co CDA that they will be conducting an all-county housing study yet in 2023. They will be using Maxfield as their consultant. Staff will share information when provided. WSB housing study is set to be completed in August.

B. Façade Program

Hallquist reported that the City Council approved the NYA Façade Improvement Loan Program at the July 24th Council meeting. Staff is working with the city attorney for the correct language on the loan agreement and promissory note. Staff will share information about the program via the chamber, newsletter, and snail mail to target business areas starting in September.

C. Central Trades & Advisory Group Update

Hallquist reported that the CTA group will resume meetings in September 2023. The 2023 NYA Manufacturer's Today event will be held on Wednesday, October 25th. More details to come.

D. 2024 Proposed Goals & Budget

Hallquist presented proposed goals and budget for 2024. The following were added:

- Budget for and fund up to \$20,000 NYA Façade Improvement Loan Program
- Identify redevelopment opportunities (commercial)
- Increase efforts to attract housing development
- Promote available land development opportunities
- Identify redevelopment opportunities (housing)
- Invest in new light pole banners for the historic downtowns and Hwy 212 corridor
- Invest in a new city website

MM asked fi there could be a QR code to link to the NYA commercial and put on more marketing items. CL suggested doing a photography contest and use the "Best of NYA" pictures to be displayed in a public place

7.D 2024 Goals & Budget


Staff has proposed the attached 2024 Goals and a budget as follows:


