1. Call to Order

2. Adoption of Agenda

Motion: BG/DS to adopt the agenda as written. Motion passed 6-0.

3. Approve Minutes

A. May 16, 2023, June 20, 2023, Parks & Recreation Meeting

Motion: KH/JZ to approve the minutes. Motion passed 6-0.

4. Introductions, Presentations, and Public Comment – Hallquist welcomed the new District 108 Community Ed representative Brooke Raether.

5. New Business

A. National Fitness Campaign Presentation

Hallquist shared information on a new campaign for good health by Blue Cross Blue Shield of MN. BCBS partnered with the National Fitness Campaign to bring ten (10) Fitness Courts to MN each year starting in 2024. These are open-air courts with circuit equipment. Staff viewed a demo for the program as attached in the packet.

Highlights include:

- Fitness courts are made of the same materials as playground equipment, so it is weather resistant.
- The Fitness courts are ageless anyone can use them.
- NFC offers an app that offers guidance to those who want to use it as an exercise regimen.
- NFC makes a large production of the planning, installation, and marketing of each project to bring attention to the community and beyond.
- The Fitness Courts are a new "niche" which draws people to the community.
- BCBS and NFC offer grants up to \$75,000 (includes structure and artwork)
- City fund commitments can be a range of \$135,000-177,000
- Potential for outside sponsorship opportunities SHIP, local clinics, etc.

Commissioners agreed to keep this idea on the "back burner" for a future project. Because facilities like this are limited, it would not only be an amenity to the community but also a tourism draw for visitors.

B. 2023 Goals Review & 2024 Goals Proposed

Commissioners reviewed the 2023 Goals which had the following three items still in progress:

- Research/development of Outlot A
- Completion of Old Town
- Continuing the All- Park Assessment

Discussion on some proposed additions for 2024 included:

- Research/install disc golf to add to Prairie awn Park
- Research adding additional touches to the mural at Willkommen Memorial Park

Commissioners agreed that the Old Town project has limited their funding other projects, however, it is near completion and can plan for future projects starting in 2025. Hallquist shared larger future projects that have been submitted to the City Council to add to the Capital Improvement Plan (CIP):

- Outlot A completion
- Tennis Courts at Friendship Park
- Playground replacement every four (4) years starting in 2027
- Concrete the hockey rink (boards were replaced not long ago they just need paint)
- New signage at NYA Sports Complex and South Park

6. Old Business/Updates

A. Old Town Update

Hallquist shared that at the next Council meeting, Old Town will be talked about again and voted on whether to pursue the project or not. YA Cardinals and Stiftungsfest representatives will be there to commit to helping ask for donations and pledge money to the project.

B. All Park Assessment Update

Hallquist shared that City Staff has been working on maintenance projects at all of the parks. One large task completed was new mulch and border at NYA Sports Complex Lions playground. Staff is working on calculating the use zones of the other playgrounds for new mulch and borders as well. Staff will bring information on Casper Park at the next meeting.

C. Tree Program

Hallquist reported that the Memorial Tree Program brochure was updated to include:

- Offering four types of trees (Maple, Crabapple, Oak, or Evergreen) for a price of \$400 which includes the tree, memorial certificate, delivery and planting.
- Trees will be planted in the spring and fall. Donators will be notified of the date of the planting.
- Donators have the option of selected parks to plant the tree, with reserving NYA Legion Park and Veteran's Park for those honoring a veteran.
- Donators have an option of purchasing a "Tree Hugger Plaque" for an additional cost of \$54.95. The Tree Hugger Plaque is made of stainless steel it will not rust and can be engraved with up to 5 lines of 35 characters each. The plaque comes with a small or large spring encased in plastic to protect and grow with the tree. The city holds no liability for the plaque.

Motion by DS/SF to recommend approval of the Memorial Tree Program to the City Council. Motion passed 6-0.

High Work

Preliminary estimate to sandblast and paint eight light poles.

There is an extensive amount of time and labor in preparation of the work area to accommodate lifts and heavy equipment required to do the job.

We would use black diamond sand for the sandblasting portion. This is eco friendly.

We would put drop cloths and tarps to catch as much of the falling debris as possible. The remaining bits would be miniscule and insignificant.

After sandblasting we would have to immediately coat the bare metal to ensure a solid bond to clean material.

This means we would spend the first half the day sandblasting as much is possible, the second half of the day applying the primer coat.

We would have to bring in an 85 foot lift using swamp pads to protect the grounds and plywood to minimize the impact.

We would start the paint process below the Light basket and paint the Metal pole

The baskets are hot dipped and galvanized. This does not require an additional coat. My company is equipped and capable of doing all high work and labor. I would be renting equipment from Hanson sandblasting my cousin.

We would be using rust oleum 9100. A proxy finish color yet to be decided.

The estimated cost at the minimum would be \$9000-\$13,000 per tower.

There are just too many moving parts on this particular job to give you a solid estimate until we can get out there and do some testing.



RE: All-Park Assessment Update – Casper Park

The "use zone" is defined as "the surface under and around the equipment onto which a child accidentally falling from or exiting from the equipment would be expected to land." The following standards were suggested to the City of NYA by the League of MN Cities (Parks and Recreation Loss Control Guide and Public Playground Safety Handbook) to calculate the playground use zones at Casper Park:

- Use zones should extend at least 6 ft in all directions from the edge of stationary equipment.
- Use zones should have soft landing material and be free from other obstacles or equipment.
- The use zone for a swing should extend two times the height of the pivot or swing hanger in front of and behind the swing seats.



Casper Park Use Zone

- Swing Use Zone requires 40 ft front to back, 44 ft side to side = 1760 sf
 - There is only 12.5 ft from the swing swivel point to the property line, leaving 7.5 ft short of the required 20 ft behind the swings for the safe use zone.

- Slide Use Zone requires 24 ft front to back and 14 ft wide = 336 sf
- Twirly Toy Use Zone requires approx. 220 sf around the toy = 220 sf
- Two Spring Toys have been removed due to "pinch-points"
- Total square footage of use zone for Casper Park = approx. 2,300 sf (use zones shown as approximates on map)

Based on the use zone results, there is not an acceptable amount of city-owned space to accommodate the use zone requirements as it impedes private property.

According to the Public Playground Safety Handbook, pea gravel is an acceptable surface impact material, however, the LMC representative suggested reevaluating the material used when correcting the use zones. Staff researched the cost of complete replacement of the surface impact material (2,300 sf) to playground certified mulch and border.

- Playground certified mulch (12" base) \$2,300
- Plastic border \$1,300
- Plus cost of disposal current material

The LMC representative also commented on the rusted hinges on the swing set and the large spaces between rails, platforms and limited rails on the slide which could result in a falling incident.

Staff is recommending Commissioners to take the next steps to decommission Casper Park based on the research provided for the required use zone, expense of fixing or replacing equipment, and lack of public use due to inaccessibility. The next steps would include collecting information from the city attorney on options available for the land after the decommissioning, bringing information to the City Council for discussion and eventually holding a public hearing.
